## Anti-Ragging Committee

### Functions:

1. **Anti-Ragging Squad:** A smaller, mobile group of staff members tasked with surprise inspections and monitoring.
2. **Mentorship Programs:** Committee shall sensitize senior students mentor freshers in a positive and structured way.
3. **Orientation Programs:** Committee may conduct sessions for newcomers to inform them of rules, rights, and contact points for reporting ragging.
4. **Undertakings:** Committee shall ensure that every student and parent signs an Anti-Ragging Affidavit during admission, affirming non-involvement in ragging.
5. **Preventive Measures:** Conduct awareness and sensitization programs for students. Display relevant information about the Anti- Ragging and complaint mechanism across campus.
6. The committee is expected to meet at least twice a year for review and oversight.

### Punishment for Ragging:

- Suspension from attending classes.
- Withholding of scholarships/fellowships.
- Debarring from exams/admissions.
- Expulsion from the University.
- Legal prosecution under Indian Penal Code (IPC).
